MONITOR RESPONSIBILITIES

- Arrive at the gym at least 15 minutes before gym opens.
- Collect and receipt \$2.00 per participant per night. 2.
- Have each participant complete and sign the Wavier/Sign-in sheet each night. 3.
- Monitor the facility and participants during the open gym hours of operation. 4.
- At the end of the evening, make sure gym is clean and doors are locked. 5.
- Turn in all money collected and the Waver/Sign-in sheet to the Douglas County Recreation Division 's night drop 6. box after each evening.
- Turn in your completed time sheet of dates worked to the Recreation Division. 7.
- Notify the Recreation Coordinator of any incidents including accidents, fighting or unsportsmakelike conduct. 8.
- Notify the Recreation Coordinator or the Recreation Division if you are unable to work at least 24 hours in advance 9. so another monitor can be scheduled.

DOUGLAS COUNTY PARKS & RECREATION DEPARTMENT RESPONSIBILITIES

The Recreation Coordinator will notify you of any changes in the schedule.

This agreement may also be terminated by any party upon (30) days written notice to the other party. The County may cause immediate termination in instances where other employees could be terminated such as drinking on the job, immoral behavior, insubordination, breach of contract, or any action in violation of County Personnel Policies (DDC 2.02.080). Acknowledged that the contracted monitor is not a Douglas County employee and there shall be no withholding of income taxes by Douglas County, participation in group insurance plans which may be available to classified employees of Douglas county, accumulation of vacation, sick or holiday leave or unemployment compensation provided by Douglas County.
