DEFAULT ORDER AND JUDGMENT

14 This matter was heard on May 23, 1997, before Jeffry
15 L. Millward, Child Support Hearing Master, with the following
16 persons present:

17 Petitioner was present and represented by the Douglas
18 County District Attorney's Office.

19 Respondent was duly served but failed to appear by
20 himself or through counsel and did not request a continuance.

21 The Child Support Hearing Master has reviewed all
22 pleadings and papers on file herein, and makes this order by way
23 of default.

AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:

24 That the Court has jurisdiction of the parties and
25 subject matter of this case.

26 That the defendant was served with the Notice of
27 Intent to Enforce and/or Modify an Order and Notice of Hearing
28 by signing for Certified Mail on April 18, 1997.

That the defendant is the parent of the following
children:

MICHAEL ADRIANN CONKLIN Born: 02/08/77, now emancipated
LUKE DEAN CONKLIN Born: 02/09/81

1 That the defendant owes a duty of support to the
2 following child:

3 LUKE DEAN CONKLIN Born: 02/09/81

4 That \$500.00 per month is a reasonable amount of
5 ongoing child support for defendant to pay.

6 That in the parties' divorce decree filed August 4,
7 1988, defendant was ordered to pay \$200.00 per month per child,
8 for a total of \$400.00 per month as ongoing child support.

9 That in a modification of the parties' divorce decree
10 filed June 8, 1992, defendant was ordered to pay \$500.00 per
11 month per child, for a total of \$1,000.00 per month, minus
12 \$109.25, which sum represented one-half of his medical insurance
13 premium, for a total of \$890.75 per month.

14 That the defendant's medical insurance coverage for
15 his minor child Luke Dean Conklin ended December 2, 1996.

16 That the defendant's insurance coverage for his minor
17 child Luke Dean Conklin should be reinstated effective June 1,
18 1997.

19 That the defendant owes child support arrears in the
20 amount of \$1,060.00 for the period December 1996 through and
21 including May 23, 1997.

22 The Court further finds that the defendant should pay
23 a monthly sum of \$50.00 toward satisfaction of child support
24 arrears and that interest on the amount of the judgment shall
25 accrue at the rate set by NRS 99.040.

26 **THEREFORE, IT IS HEREBY ORDERED THAT:**

27 That the defendant is the parent of the following
28 children:

MICHAEL ADRIANN CONKLIN Born: 02/08/77, now emancipated
LUKE DEAN CONKLIN Born: 02/09/81

Judgment is entered in favor of plaintiff and against
defendant in the amount of \$1,060.00 for the period December
1996, through and including May 23, 1997.

Interest upon the amount of the judgment for arrears
shall accrue at the rate set by NRS 99.040.

5 The defendant will secure and maintain medical health
6 insurance on the above named child when available through
7 employment or other group policy. The Defendant is ordered to
8 continue, upon the request of the Douglas County District
Attorney's Office, to provide it with information regarding the
availability of health insurance.

9 The defendant shall notify the Douglas County District
10 Attorney's Office of any change in home address, mailing address,
11 telephone number, employment, or medical insurance availability
within ten days of any change.

12 **IT IS FURTHER ORDERED THAT:**

13 Defendant's first monthly child support
14 obligation shall be due on the first day of June,
15 1997, and shall continue due on the first day of
16 each and every month thereafter until further order
of this court.

17 That when defendant's minor child emancipates,
18 defendant shall continue to pay \$500.00 per month
19 toward satisfaction of then existing child support
arrearages in accordance with NRS 125B.100.

20 That defendant's ordered monthly payment on
21 child support arrearages does not preclude other
22 methods of collection for child support arrearages.

23 This support order shall be reviewed every
24 three years in accordance with NRS 125B.145.

25 That defendant's monthly child support
26 payments shall be in the form of a cashier's
27 check, certified check, or money order, or in
28 cash. If the payment is in the form of cash, it
must be delivered to the Douglas County Clerk at
her office in Minden, Nevada. If the payment is in
the form of a cashier's check, certified check, or
money order, it must be made payable to the
DOUGLAS COUNTY CLERK, must contain the notation
Case No. 970067 (CONKLIN), and be either mailed
to the Douglas County Clerk at Post Office Box
1240, Minden, Nevada 89423, or delivered to
said County Clerk at her office the Minden Inn,
1594 Esmeralda Avenue, Suite 105, Minden, Nevada.
The Douglas County Clerk shall transmit said
payments to: PHYLLIS ELAINE DAVENPORT.

OBJECTIONS TO THIS ORDER MAY BE FILED WITH THE
DISTRICT COURT AND SERVED UPON THE OTHER PARTY WITHIN TEN (10)

1 DAYS OF RECEIPT OF THE CHILD SUPPORT HEARING MASTER'S
2 RECOMMENDATIONS.
