That the defendant was served with the Notice of 24 Intent to Enforce and/or Modify an Order and Notice of Hearing by signing for Certified Mail on April 18, 1997. 25 That the defendant is the parent of the following 26 children: 27 MICHAEL ADRIANN CONKLIN Born: 02/08/77, now emancipated 28 LUKE DEAN CONKLIN Born: 02/09/81 0414689

That the defendant owes a duty of support to the following child:

LUKE DEAN CONKLIN Born: 02/09/81

That \$500.00 per month is a reasonable amount of ongoing child support for defendant to pay.

That in the parties' divorce decree filed August 4, 1988, defendant was ordered to pay \$200.00 per month per child, for a total of \$400.00 per month as ongoing child support.

That in a modification of the parties' divorce decree filed June 8, 1992, defendant was ordered to pay \$500.00 per month per child, for a total of \$1,000.00 per month, minus \$109.25, which sum represented one-half of his medical insurance premium, for a total of \$890.75 per month.

That the defendant's medical insurance coverage for his minor child Luke Dean Conklin ended December 2, 1996.

That the defendant's insurance coverage for his minor child Luke Dean Conklin should be reinstated effective June 1, 1997.

That the defendant owes child support arrears in the amount of \$1,060.00 for the period December 1996 through and including May 23, 1997.

The Court further finds that the defendant should pay a monthly sum of \$50.00 toward satisfaction of child support arrears and that interest on the amount of the judgment shall accrue at the rate set by NRS 99.040.

THEREFORE, IT IS HEREBY ORDERED THAT:

That the defendant is the parent of the following children:

Judgment is entered in favor of plaintiff and against defendant in the amount of \$1,060.00 for the period December 1996, through and including May 23, 1997.

The Defendant is ordered to continue, upon the request of the Douglas County District Attorney's Office, to provide it with information regarding the availability of health insurance.

The defendant shall notify the Douglas County District Attorney's Office of any change in home address, mailing address, telephone number, employment, or medical insurance availability within ten days of any change.

IT IS FURTHER ORDERED THAT:

Defendant's first monthly child support obligation shall be due on the first day of June, 1997, and shall continue due on the first day of each and every month thereafter until further order of this court.

That when defendant's minor child emancipates, defendant shall continue to pay \$500.00 per month toward satisfaction of then existing child support arrears in accordance with NRS 125B.100.

That defendant's ordered monthly payment on child support arrearages does not preclude other methods of collection for child support arrears.

This support order shall be reviewed every three years in accordance with NRS 125B.145.
