#### CONTRACT FOR SERVICES OF INDEPENDENT CONTRACTOR

The parties to this agreement are DOUGLAS COUNTY, NEVADA acting by and through the Douglas County Sheriff-Coroner's Department and its Sheriff Jerry Maple hereafter refered to as DOUGLAS COUNTY, NEVADA and the PRIMARY MEDICAL GROUP, hereinafter referred to as CONTRACTOR. CONTRACTOR defined as signee or his qualified designee.

### **PREAMBLE**

WHEREAS, it is deemed that the services of CONTRACTOR herein specified are both necessary and desirable and in the best interest of DOUGLAS COUNTY, NEVADA; and

WHEREAS, CONTRACTOR represents that he/she is duly qualified and able to render the services as hereinafter described;

- 1. This contract shall be effective from the 1st day of September 1997 to the 31st day of August 1997 unless sooner revoked by either party as set forth in paragraph two (2).
- 2. This contract may be revoked without cause by either party prior to the ending date set forth in paragraph one (1), provided that a revocation shall not be effective until ninety (90) days after a party served written notice upon the other party.
- 3. The parties agree that the services to be performed are as follows:

# CONTRACTOR will perform:

- A. Those tasks listed on the attached position description
- B. Will maintain a schedule of services as follows:

Monday, Wednesday, Friday

- Minden Jail Facility

Monday and Friday

- Lake Tahoe Jail Facility

(Preferable during A.M. hours; or as otherwise pre-arranged and agreed upon.

- C. The CONTRACTOR will provide malpractice insurance
- D. The CONTRACTOR shall see to the medical needs of inmates, make a sanitation inspection of the culinary and surrounding areas with the assistance of a deputy, make regular sanitation and cleanliness inspections of the cellblocks.
- E. The CONTRACTOR shall assure compliance with NCCHC guidelines regarding Jail Medical Facilities, insure proper stocking and security for all medical supplies including medication.
- F. The CONTRACTOR shall, in the event of a medical emergency, assure that normal protocol is followed for transportation and disposition of the inmates as necessary.
- G. The CONTRACTOR shall keep and record that information necessary to insure the proper care of inmates, provide legal documentation of same and comply with all essential standards as set forth by NCCHC guidelines.
- H. The CONTRACTOR shall provide the Jail Administration with reports, inspections analysis and purchases under documentation as required by NCCHC guidelines and the Douglas County Sheriff-Coroner's Office Administration.
- I. The CONTRACTOR shall maintain the medication inventory log, dispensation log and an adequate supply of those medications deemed appropriate to be stored in the medical lockers of the facilities.

- All records and duties pertaining to the Jails shall be subject to inspection by Sheriff-Coroner's J. Office for compliance. This action is not to infringe on client-physician privilege:
- CONTRACTOR agrees to provide the services set forth in paragraph three (3) and on the attached 4. position description to the following schedule.
  - A. \$ 42,940.80 annually
  - CONTRACTOR will not be compensated for any hours the contractor is not actually performing B. services to the COUNTY.

DOUGLAS COUNTY, NEVADA agrees to pay CONTRACTOR wages due in installments as follows: Monthly commencing in July 1997.

- This contract will be construed and interpreted according to the laws of the State of Nevada. 5.
- With the exception of a qualified designated PACC/RN, the CONTRACTOR shall neither assign, Ó. transfer, nor delegate any rights, obligations, or duties under this agreement without prior written consent of DOUGLAS COUNTY, NEVADA
- CONTRACTOR agrees to indemnify, save and hold DOUGLAS COUNTY, NEVADA its agents 7. and employees harmless from any and all claims, causes of action or liabilities arising from the performance of this agreement by the CONTRACTOR. The parties agree that CONTRACTOR is an independent contractor and is not a classified employee entitled to the protection and benefits authorized by the Classified Merit System of DOUGLAS COUNTY, NEVADA. Accordingly, CONTRACTOR understands and acknowledges that he is not a DOUGLAS COUNTY, NEVADA employee and that there shall be no:
  - Withholding of income taxes by DOUGLAS COUNTY, NEVADA; A.
  - Participation in group insurance plans which may be available to the classified employees B. of DOUGLAS COUNTY, NEVADA;
  - Accumulation of vacation, sick or holiday leave; and,
  - Unemployment compensation provided by DOUGLAS COUNTY, NEVADA. D.

The term of this agreement is one (1) year commencing the first day of September 1997.

This contract shall constitute the entire agreement between the parties and may only be modified 8. by a written agreement signed by the parties and approved by the Douglas County Board of Commissioners.

- 5. Attend Quarterly meetings with Jail Medical Staff.
- 6. Participate in NCCHC Jail evaluations for continued accreditation
- 7. Evaluate and approve standing orders and the Jail Medical Manual.
