

THE RIDGE TAHOE GRANT, BARGAIN, SALE DEED

THIS INDENTURE, made this 11th day of JUNE, 19 97 between HARICH TAHOE DEVELOPMENTS, a Nevada general partnership, Grantor, and KEITH B. BURRESS and CHRISTINA M. BURRESS, husband and wife as joint tenants with right of survivorship
