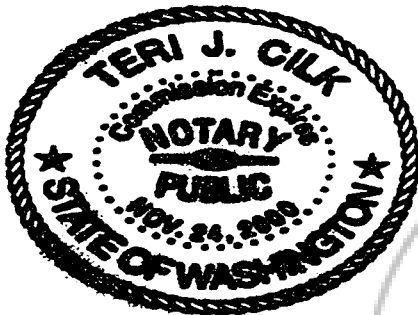

PARCEL ONE
