3 THE ELIZABETH R. BRUNSON TRUST
4 DECLARATION AND INSTRUMENT OF TRUST
5

6 I. Trust Name

7 This trust shall be known as The Elizabeth R. Brunson
8 Trust.

9 II. Trust Property

10 (A) Elizabeth R. Brunson, called the "settlor" or
11 "trustee", declares that she has set aside and holds in
12 the Elizabeth R. Brunson Trust, all her interest in that
13 property described in the attached Schedule A.

14 The trust property shall be used for the benefit of the
15 trust beneficiaries, and shall be administered and
16 distributed by the trustees in accordance with this trust
17 instrument.

18 (B) Additional or after-acquired property may be added
19 to the trust by listing it on the appropriate schedule.

20 III. Reserved Powers of Settlor

21 (A) The settlor reserves the power to amend or revoke
22 this trust at any time during her lifetime, without
23 notifying any beneficiary.

24 (B) Until the death of the settlor, all rights to
25 income, profits, or control of the trust property shall be
26 retained by or distributed to the settlor.

3 (C) If at any time, as certified in writing by a
4 licensed physician, the settlor has become physically or
5 mentally incapacitated, the successor trustee shall manage
6 this trust, and shall apply for the benefit of the settlor
7 any amount of trust income, or trust principal, necessary
8 in the trustee's discretion for the proper health care,
9 support, maintenance, comfort or welfare of the settlor,
10 in accordance with her accustomed manner of living, until
11 the settlor, as certified by a licensed physician, is
12 again able to manage her own affairs, or until her death.

13 Any income in excess of amounts applied for the benefit
14 of the settlor shall be accumulated and added to the trust
15 property.

16 (D) After the death of the settlor, this trust becomes
17 irrevocable and may not be altered or amended in any
18 respect unless specifically authorized by this instrument,
19 and may not be terminated except through distributions
20 permitted by this instrument.

21 IV. Trustees

22 (A) The trustee of The Elizabeth R. Brunson Trust shall
23 be Elizabeth R. Brunson. Upon the death of the trustee,
24 or her incapacity as certified by a licensed physician,
25 the successor trustees shall be Michael A. von Huene and
26 Mark J. von Huene (AKA Marc J. von Huene).

2 (B) Any trustee shall have the right to appoint, in
3 writing which shall be notarized, additional successor
4 trustees to serve in the order nominated if all successor
5 trustees named in Paragraph IV(A) cannot serve as trustee.

6 (C) As used in this instrument, the term "trustee"
7 shall include any successor trustee.

8 (D) No bond shall be required of any trustee.

9 (E) Except as provided in Paragraph VI(D)(2), no
10 trustee shall receive any compensation.

11 V. Beneficiaries.

12 (A) Upon the death of the settlor, the specific
13 beneficiaries of The Elizabeth R. Brunson Trust shall be:

14 1. Gail E. von Huene shall be given all of my personal
15 and household belongings as well as any vehicles I own at
16 the time of my death. With the exception of my gold
17 necklace with small diamond which is to be given to Jan
18 Christensen (702) 588-2357. The above items are to be
19 retained by Gail E. von Huene or disposed of at the
20 discription of Gail E. von Huene.

21 2. In the event Gail E. von Huene should preceed me in
22 death, all items mentioned in paragraph 1 shall be divided
23 between my two executors, Michael A. von Huene and Mark J.
24 von Huene.

25 3. Any monetary distribution so stated to any of my
26

2 beneficiaries in any of my accounts are hereby declared
3 null and void.

4 All monies are to be distributed as follows: 1/5
5 to Mark J. von Huene; 1/5 to Conner von Huene; 1/5 to
6 Jason von Huene; 2/5 to Michael A. von Huene.

7 One-half of the monies distributed to Michael A.
8 von Huene is to be put into a Trust Account for
9 Christopher von Huene with Michael A. von Huene acting as
10 trustee. The money is to be given to Christopher von
11 Huene at the discession of Michael A. von Huene.

12 (C) Upon the death of the settlor, the executors shall
13 distribute the trust property outright to the beneficiary
14 named in Paragraph V(A) (1).

15 (D) Upon the death of the settlor, the executors shall
16 use any monies in the NWC Federal Credit Union account and
17 in the personal bank savings and checking accounts of the
18 trustee to pay for the cremation and disposal of said
19 trustees remains. Trustees remains shall be placed in a
20 suitable location both executors deem acceptable.

21 VI. Trustee's Powers and Duties.

22 (A) To carry out the provisions of The Elizabeth R.
23 Brunson Trust, the trustee shall have all authority and
24 powers allowed or conferred on a trustee under Nevada law
25 and subject to the trustee's fiduciary duty to the settlor

2 and the beneficiaries.

3 (B) The settlor's debts and death taxes shall be paid
4 by the trustee from the following trust property:

5 Any monies in bank accounts or savings accounts or
6 the sale of any property chosen by the trustee.


7 If this property is insufficient to pay all the
8 settlor's debts and death taxes, the trustee shall
9 determine how such debts and death taxes shall be paid.

10 VII. General Administrative Provisions.

11 (A) The validity of The Elizabeth R. Brunson Trust and
12 the construction of its beneficial provisions shall be
13 governed by the laws of Nevada.

14 (B) If any provisions of this Trust is held to be
15 unenforceable, the remaining provisions shall be
16 nevertheless carried into effect.
