THE ELIZABETH R. BRUNSON TRUST DECLARATION AND INSTRUMENT OF TRUST

I. Trust Name

This trust shall be known as The Elizabeth R. Brunson Trust.

II. Trust Property

(A) Elizabeth R. Brunson, called the "settlor" or "trustee", declares that she has set aside and holds in the Elizabeth R. Brunson Trust, all her interest in that property described in the attached Schedule A.

The trust property shall be used for the benefit of the trust beneficiaries, and shall be administered and distributed by the trustees in accordance with this trust instrument.

- (B) Additional or after-acquired property may be added to the trust by listing it on the appropriate schedule.

 III. Reserved Powers of Settlor
- (A) The settlor reserves the power to amend or revoke this trust at any time during her lifetime, without notifying any beneficiary.
- (B) Until the death of the settlor, all rights to income, profits, or control of the trust property shall be retained by or distributed to the settlor.

(C) If at any time, as certified in writing by a licensed physician, the settlor has become physically or mentally incapacitated, the successor trustee shall manage this trust, and shall apply for the benefit of the settlor any amount of trust income, or trust principal, necessary in the trustee's discretion for the proper health care, support, maintenance, comfort or welfare of the settlor, in accordance with her accustomed manner of living, until the settlor, as certified by a licensed physician, is again able to manage her own affairs, or until her death.

Any income in excess of amounts applied for the benefit of the settlor shall be accumulated and added to the trust property.

(D) After the death of the settlor, this trust becomes irrevocable and may not be altered or amended in any respect unless specifically authorized by this instrument, and may not be terminated except through distributions permitted by this instrument.

IV. Trustees

(A) The trustee of The Elizabeth R. Brunson Trust shall be Elizabeth R. Brunson. Upon the death of the trustee, or her incapacity as certified by a licensed physician, the successor trustees shall be Michael A. von Huene and Mark J. von Huene (AKA Marc J. von Huene).

- Any trustee shall have the right to appoint, in (B) writing which shall be notarized, additional successor trustees to serve in the order nominated if all successor trustees named in Paragraph IV(A) cannot serve as trustee.
- As used in this instrument, the term "trustee" (C) shall include any successor trustee.
 - No bond shall be required of any trustee. (D)
- Except as provided in Paragraph VI(D)(2), no (E) trustee shall receive any compensation.
- V. Beneficiaries.
- Upon the death of the settlor, the specific (A) beneficiaries of The Elizabeth R. Brunson Trust shall be:
- Gail E. von Huene shall be given all of my personal and household belongings as well as any vehicles I own at the time of my death. With the exception of my gold necklace with small diamond which is to be given to Jan Christensen (702) 588-2357. The above items are to be retained by Gail E. von Huene or disposed of at the discression of Gail E. von Huene.
- In the event Gail E. von Huene should preceed me in 2. death, all items mentioned in paragraph 1 shall be divided between my two executors, Michael A. von Huene and Mark J. von Huene.
 - з. Any monetary distribution so stated to any of my

beneficiaries in any of my accounts are hereby declared null and void.

All monies are to be distributed as follows: 1/5 to Mark J. von Huene; 1/5 to Conner von Huene; 1/5 to Jason von Huene; 2/5 to Michael A. von Huene.

One-half of the monies distributed to Michael A.

von Huene is to be put into a Trust Account for

Christopher von Huene with Michael A. von Huene acting as

trustee. The money is to be given to Christopher von

Huene at the discression of Michael A. von Huene.

- (C) Upon the death of the settlor, the executors shall distribute the trust property outright to the beneficiary named in Paragraph V(A) (1).
- (D) Upon the death of the settlor, the executors shall use any monies in the NWC Federal Credit Union account and in the personal bank savings and checking accounts of the trustee to pay for the cremation and disposal of said trustees remains. Trustees remains shall be placed in a suitable location both executors deem acceptable.
- VI. Trustee's Powers and Duties.
- (A) To carry out the provisions of The Elizabeth R.

 Brunson Trust, the trustee shall have all authority and powers allowed or conferred on a trustee under Nevada law and subject to the trustee's fiduciary duty to the settlor

and the beneficiaries.

(B) The settlor's debts and death taxes shall be paid by the trustee from the following trust property:

Any monies in bank accounts or savings accounts or the sale of any property chosen by the trustee.

If this property is insufficient to pay all the settlor's debts and death taxes, the trustee shall determine how such debts and death taxes shall be paid.

VII. General Administrative Provisions.

- (A) The validity of The Elizabeth R. Brunson Trust and the construction of its beneficial provisions shall be governed by the laws of Nevada.
- (B) If any provisions of this Trust is held to be unenforceable, the remaining provisions shall be nevertheless carried into effect.
