

1 THIS INDENTURE, made the 2nd day of January, one thousand
 2 nine hundred and forty one, BETWEEN, H. D. Wilson and Florence
 3 Neely Wilson, husband and wife, of Elks Point, Douglas County,
 4 Nevada, the parties of the first part, and Leslie Drappo and Norma
 5 Drappo, husband and wife, of Reno, Washoe County, Nevada, the
 6 parties of the second part,

7 W I T N E S S E T H:

8 That the said parties of the first part, in consideration
 9 of the sum of Ten (\$10.00) dollars, lawful money of the United
 10 States of America, to them in hand paid by the parties of the
 11 second part, the receipt whereof is hereby acknowledged, does by
 12 these presents, GRANT, BARGAIN and SELL unto the said parties of
 13 the second part, and to their heirs and assigns forever, all of
 14 the following described land, situate, lying and being at Elks
 15 Point (Lake Tahoe), Douglas County, Nevada, and more particularly
 16 described as follows, to-wit:

17 Lot Numbered 93, as the same is laid down, de-
 18 linedated and numbered upon a certain map en-
 19 titled "Elks Subdivision Lake Tahoe, Nev"., filed in the office of the County Recorder of
 20 said County of Douglas, May 5, 1927 reserving
 21 and excepting therefrom, however, a wedge
 22 shaped parcel of land extending along the east
 23 side of said lot which parcel of land is five
 24 (5) feet wide on its north end measuring from
 25 the northeast corner of said lot 93, its east
 26 boundary line being the boundary line common
 27 to Lot 93 and Lot 94 as shown on the map herein
 28 referred to; said parcel of land having for its
 29 western boundary a line beginning on the
 30 meander line of Lake Tahoe five (5) feet west
 31 from the north corner common to Lots 93 and 94
 32 and extending through the south corner common
 to Lots 93 and 94. Subject to the By-laws,
 rules and regulations of Elkpoint Country Club,
 Inc., as set forth in that certain deed dated
 August 31, 1927, recorded in Book S of Deeds,
 page 300, records of Douglas County, Nevada,


