- 1. - 2. That the Executrix be, and she is hereby authorized and directed to pay to ERNEST E. ADLER, ESQ., the sum of \$500.00 for attorney's fees, together with the sum of \$271.25 for his expended costs of administration, together with any closing costs.

- That there are no United States Estate tax or State of Nevada Estate tax owing.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that upon filing of appropriate receipts, that said Executrix shall be discharged of her trust, and that said estate shall be closed.
