14 COMES NOW, Plaintiff KAREN HEDY HURZEL, by and through
15 GARY L. KENDRICK, DEPUTY DISTRICT ATTORNEY, and Defendant,
16 EDWARD MARTIN SILVA II, who hereby agree and stipulate as
17 follows:

18 1. That in an Order modifying Decree of Divorce filed
19 February 1, 1993, in the Ninth Judicial District Court of the
20 State of Nevada, In and For Douglas County, Defendant was
21 ordered to pay the sum of 25% of his gross monthly income per
22 month as ongoing support of his minor children, JONATHAN
23 EDWARD SILVA Born: 09/13/85; and CHRISTOPHER MARTIN SILVA Born:
24 08/23/87.

25 2. That Defendant owes \$3,766.77 in child support
26 arrearages through and including August 31, 1997.

1 3. That Defendant currently earns \$1,239.15, average
2 per month. That based upon Defendant's monthly income and
3 applying the formulas set forth in NRS 125B.070, to wit: 25%,
4 Defendant's monthly child support obligation is \$309.00.

5 4. That Defendant is currently seeking full-time
6 employment, and the parties' agree that a financial review shall
7 be held in the District Attorney's Office on or about 9:30 am,
8 on October 14, 1997, or as soon thereafter as is practicable.

9 5. The parties stipulate and certify that the amount
10 of support is consistent with the appropriate formula set forth
11 in paragraph (b) of subsection 1 of NRS 125B.070.

12 6. That the Defendant shall pay \$309.00 per month as
13 ongoing support, plus \$25.00 per month toward satisfaction of
14 child support arrears for a total of \$334.00 per month. That
15 Defendant's first \$334.00 monthly payment shall be due on
16 September 1, 1997, and continue due on the first day of each
17 and every month thereafter until further order of this court.

18 7. That Defendant's child support payments shall be
19 made by wage withholding.

20 8. Defendant understands that, in the event he
21 becomes unemployed or underemployed, all child support payments
22 to be made by him to Plaintiff must be in the form of a
23 cashier's check, certified check, or money order, or in cash.
24 The Defendant further understands that if the payment is in the
25 form of cash it must be delivered to the Douglas County Clerk at
26 her office in Minden, Nevada. If the payment is in the form of
27 a cashier's check, certified check, or money order, Defendant

1 understands that it must be made payable to the DOUGLAS COUNTY
2 CLERK, with the notation Case No. 940287 (EDWARD MARTIN SILVA
3 II), and be either mailed to the Douglas County Clerk at Post
4 Office Box 218, Minden, Nevada 89423, or delivered to said
5 County Clerk at her office in Minden, Nevada.

6 9. That the Defendant shall provide medical insurance
7 coverage for his minor children if available through employment
8 or other group policy.

9 10. That pursuant to NRS 125B.080.7, expenses for
10 health care which are not reimbursed through insurance,
11 including expenses for medical, surgical, dental, orthodontic
12 and optical expenses, must be borne equally by both parents in
13 the absence of extraordinary circumstances.

14 11. Defendant agrees that he shall notify the Douglas
15 County District Attorney's Office in writing within 10 days of
16 any change in Defendant's mailing address, home address, or
17 employment.

18 12. Defendant understands that this support order may
19 be reviewed every three years at the request of either party in
20 accordance with NRS 125B.145.

21 13. Defendant understands that failure to pay his
22 support as required by the order entered in accordance with this
23 stipulation will subject him to possible contempt of court with
24 a penalty of 25 days in jail.

25 14. That except as modified herein the terms and
26 conditions of the order entered February 1, 1993, in the Ninth

1 Judicial District Court of the State of Nevada, In and For
2 Douglas County, shall remain in full force and effect.

3 15. Defendant understands that monthly periodic
4 payments ordered in accordance with this Stipulation do not
5 preclude the use of other means to collect any arrears or
6 enforce this order, including garnishment, liens, attachments,
7 execution on real or personal property or interception of
8 federal income tax refunds.
