### Substitution Of Trustee



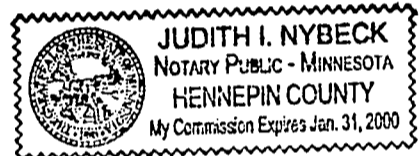




### Full Reconveyance



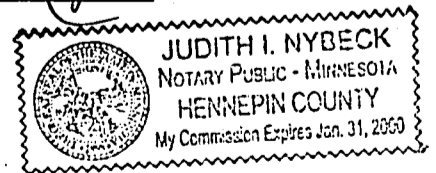
