13 This Court has reviewed plaintiff's Application for
14 Default and all pleadings and papers on file herein, and makes
15 this order by way of default.

16 Petitioner is represented by the Douglas County
17 District Attorney's Office.

18 Respondent was duly served but failed to file an
19 answer and did not request a conference with the District
20 Attorney's Office, Child Support Division.

21 **AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:**

22 That the Court has jurisdiction of the parties and
23 subject matter of this case.

24 That the defendant was served by certified mail with
25 the Notice of Finding of Financial Responsibility of May 16,
26 1997.

27 That the defendant is the parent of and owes a duty of
28 support to the following children:

- 29 DANIEL E. MCDONALD Born: 07/30/85
- 30 JOSEPH D. MCDONALD Born: 02/08/91

31 That based upon Nevada Employment Security Division
32 Records, Defendant currently earns 3,041.00 per month, working
33 as a painter. That based upon Defendant's monthly income and
34 applying the formulas set forth in NRS 125B.070, to wit: 25%,
35 Defendant's monthly child support obligation is \$760.25.

1 That the defendant owes child support arrears in the
2 amount of \$3,800.00 for the period May 1997 through and
3 including September 1997.

4 **THEREFORE, IT IS HEREBY ORDERED THAT:**

5 That the defendant is the parent of the following
6 children:

7 DANIEL E. MCDONALD Born: 07/30/85
8 JOSEPH D. MCDONALD Born: 02/08/91

9 Judgment is entered in favor of plaintiff and against
10 defendant in the amount of \$3,800.00 for the period May 1997,
11 through and including September 1997.

12 Defendant shall pay \$836.00 per month, by wage
13 withholding, to be paid as follows:

18 The defendant will secure and maintain medical health
19 insurance on the above named child when available through
20 employment or other group policy. The Defendant is ordered to
21 continue, upon the request of the Douglas County District
22 Attorney's Office, to provide it with information regarding the
23 availability of health insurance.

24 That custody of the minor children shall remain with
25 the mother, VICTORIA L. WILKINSON. This provision is made under
26 authority of NRS 126.161 (5), and is made for the protection of
27 the minor child. The parties' understand that the Douglas
28 County District Attorney's Office does not have authority to
litigate matters regarding custody and visitation.

The child's birth certificate shall be changed and an
amended birth certificate issued indicating that DANIEL JOEY
MCDONALD is the father of DANIEL E. MCDONALD Born: 07/30/85,
and JOSEPH D. MCDONALD Born: 02/08/91.

The defendant shall notify the Douglas County District
Attorney's Office of any change in home address, mailing address,
telephone number, employment, or medical insurance availability
within ten days of any change.

IT IS FURTHER ORDERED THAT:

Defendant's first monthly child support
obligation shall be due on the first day of
October, 1997, and shall continue due on the first
day of each and every month thereafter until further
order of this court.

That when defendant's minor child(ren)
emancipate(s), defendant shall continue to pay

1 \$836.00 per month toward satisfaction of then
2 existing child support arrears in accordance with
NRS 125B.100.

3 That defendant's ordered monthly payment on
4 child support arrearages does not preclude other
5 methods of collection for child support arrears.

6 This support order shall be reviewed every
7 three years in accordance with NRS 125B.145.

8 That defendant's monthly child support
9 payments shall be in the form of a cashier's
10 check, certified check, or money order, or in
11 cash. If the payment is in the form of cash, it
12 must be delivered to the Douglas County Clerk at
her office in Minden, Nevada. If the payment is in
13 the form of a cashier's check, certified check, or
14 money order, it must be made payable to the
DOUGLAS COUNTY CLERK, must contain the notation
15 Case No. 970043 (MCDONALD), and be either mailed
16 to the Douglas County Clerk at Post Office Box
17 1240, Minden, Nevada 89423, or delivered to
18 said County Clerk at her office in the Minden
19 Inn, 1594 Esmeralda Avenue, Suite 105, Minden,
20 Nevada.
