ACKNOWLEDGEMENT OF PROPERTY BOUNDARY

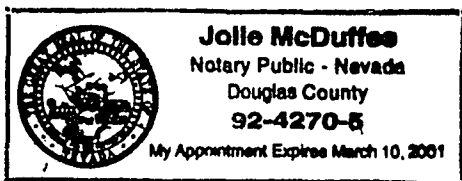
