

SUBSTITUTION OF TRUSTEE

WHEREAS, on November 8, 1987, Larry Pereira and Frances Lee Pereira, husband and wife as joint tenants with right of survivorship executed that certain deed of trust dated November 8, 1987 to Stewart Title of Douglas County, A Nevada Corporation as trustee ("Initial Trustee") for the benefit of Harich Tahoe Developments, a Nevada general partnership, beneficiary, encumbering real property situated in Douglas County, Nevada, which deed of trust was recorded in the Official Records of said County on December 9, 1987 in Book 1287 at Page 1247 as Document Number 168272 (the "Deed of Trust"); and

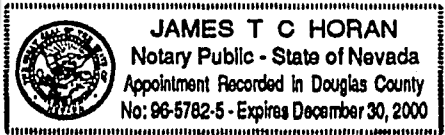
