It is hereby agreed by and between Kenneth M. Butti, applicant, and the Secretary of the Interior (United States of America), acting by and through Robert L. Hunter, Superintendent, Western Nevada Agency, Bureau of Indian Affairs, that the original Grant of Easement for Road Right-of-Way approved on July 31, 1987, be modified to provide:


“that the applicant be allowed to construct general utility services (electricity, telephone, water, sewer) within the Road Right-of-Way.”

That line 23 on the original Grant of Easement for Road Right-of-Way be changed from “the N 1/16 corner of Section 22, T. 14 N., R. 19 E., MDB&M., Nevada; thence” to “the CN 1/16 corner of Section 22, T. 14 N., R. 19 E., MDB & M., Nevada, thence”

This modification does not change any terms or conditions except as specifically set forth herein and is supported by the Washoe Tribe of Nevada and California Tribal Resolution No. 96-WTC-62, dated October 14, 1996. The legal description is a technical amendment after review by the Bureau of Land Management, Cadastral Survey Division, Reno, Nevada.

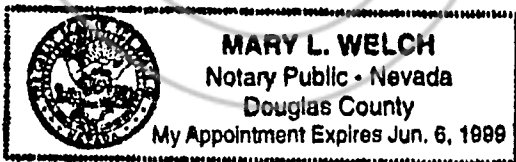

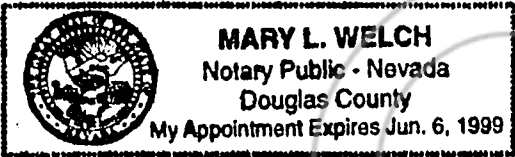
