**SUBSTITUTION OF TRUSTEE AND RECONVEYANCE**

This reconveyance is executed at the request of Successor Beneficiary.

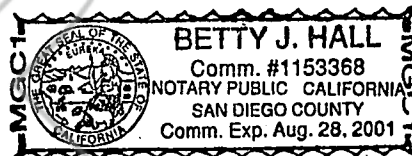
