TO HAVE AND TO HOLD, all and singular, the premises, together with the appurtenances, unto the said Grantee forever.

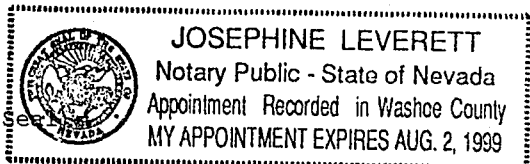
