Together with the right to use the existing Clydesdale Court and Extension thereof to serve Parcel C-2.

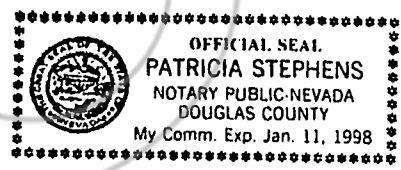
