

SUBSTITUTION OF TRUSTEE

WHEREAS, on December 30, 1988, Robert A. 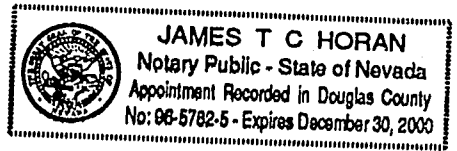

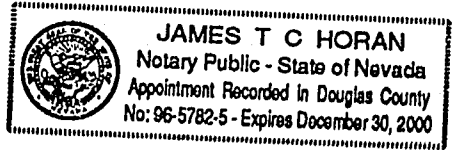
