

SUBSTITUTION OF TRUSTEE

WHEREAS, on September 2, 1995, Judith Purcell, a single woman and Christopher E. 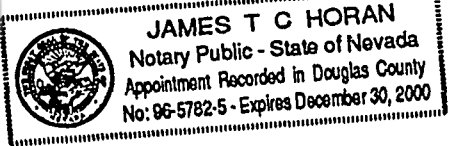

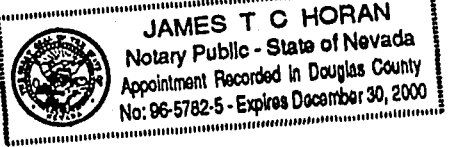
