



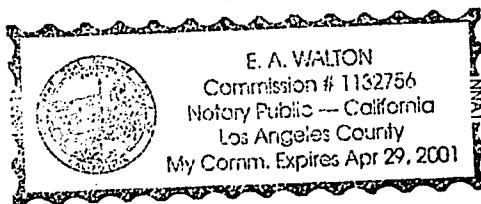

DEED OF TRUST
