

SUBSTITUTION OF TRUSTEE

WHEREAS, on January 26, 1991, Judy F. 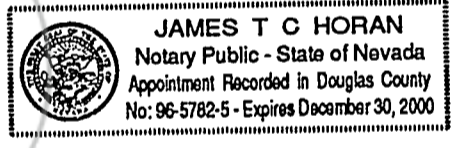

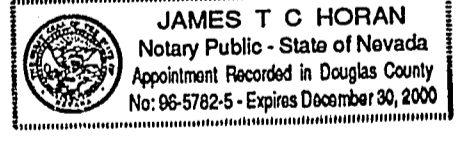
