

SUBSTITUTION OF TRUSTEE


WHEREAS, on October 29, 1995, Ernest L. Taylor and Patricia L. Taylor, husband and wife as joint tenants with right of survivorship executed that certain deed of trust dated October 29, 1995 to Stewart Title of Douglas County, A Nevada Corporation as trustee ("Initial Trustee") for the benefit of Ridge View Joint Venture, a Nevada joint venture, beneficiary, encumbering real property situated in Douglas County, Nevada, which deed of trust was recorded in the Official Records of said County on December 20, 1995 in Book 1295 at Page 2952 as Document Number 377201 (the "Deed of Trust"); and

IN WITNESS WHEREOF, this Substitution of Trustee is executed this 29th day of January, 1998.




