


SUBSTITUTION OF TRUSTEE and DEED OF RECONVEYANCE

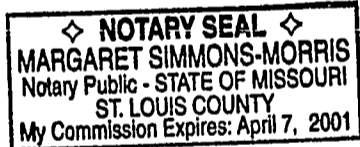
