

SUBSTITUTION OF TRUSTEE


WHEREAS, on September 20, 1996, Ann Cooke and Robert Boeltger, wife and husband as joint tenants with right of survivorship executed that certain deed of trust dated September 20, 1996 to Stewart Title of Douglas County, A Nevada Corporation as trustee ("Initial Trustee") for the benefit of Ridge View Joint Venture, a Nevada joint venture, beneficiary, encumbering real property situated in Douglas County, Nevada, which deed of trust was recorded in the Official Records of said County on September 30, 1996 in Book 996 at Page 4927 as Document Number 397510 (the "Deed of Trust"); and

IN WITNESS WHEREOF, this Substitution of Trustee is executed this 2nd day of March, 1998.






