

SUBSTITUTION OF TRUSTEE

WHEREAS, on March 16, 1995, Phillip S. 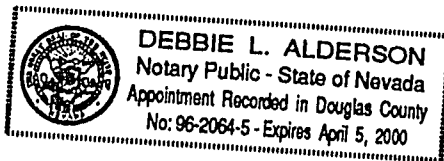

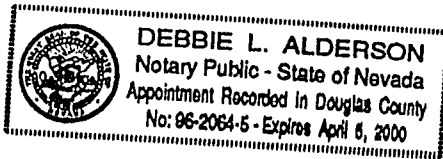
