

SUBSTITUTION OF TRUSTEE

WHEREAS, on May 22, 1992, Tonya L. Sackett, a single woman and Marion D. 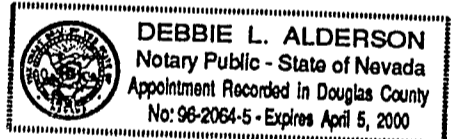

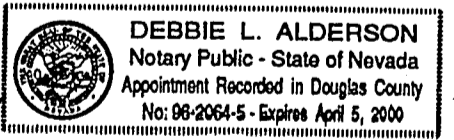
