SHORT FORM DEED OF TRUST

This Deed of Trust is made on May 19, 1998 by ROGER G. AUDINO, AN UNMARRIED PERSON

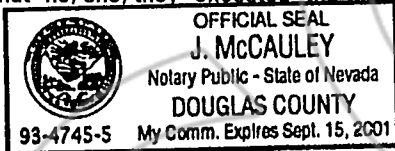
