THIS MATTER came on regularly for hearing before the undersigned District Judge on the
14 4th day of August, 1997 at the hour of 1:30 P.M. upon the Administrator's Final Accounting and
15 Petition for Final Distribution. WILLIAM V. REYNOLDS was present in Court and was
16 represented by HERMAN G. HERBIG, ESQ. Good cause appearing therefor;

IT IS HEREBY ORDERED that the Administrator's final accounting is settled and approved
19 and the acts of WILLIAM V. REYNOLDS as Administrator are confirmed;

IT IS FURTHER ORDERED that Petitioner is authorized and directed to pay the claims of
22 creditors as outlined in the Petition;

IT IS FURTHER ORDERED that Petitioner may make a partial distribution of the remaining
24 residuary estate of the Decedent together with all other property of the Estate not now known or
25 hereafter discovered as set forth therein;

IT IS FURTHER ORDERED that Petitioner is allowed to pay final costs of administration as
28 may be expended by him for publication of notice, certified copies, bookkeeping, preparation of tax

1 returns, and the payment of any taxes which may be determined to be due by the Estate, and other
2 winding up expenses in connection with the closing of this Estate, not to exceed TWO THOUSAND
3 DOLLARS (\$2,000);
4

5 IT IS FURTHER ORDERED that the Administrator shall undertake reasonable efforts to
6 recover a certain taxidermy mount and certain funds on deposit with Bank of America and upon
7 recovery of the same, distribute them to the heir as set forth in the Petition.

8 IT IS FURTHER ORDERED that Petitioner shall distribute the real property located in
9 Douglas County, State of Nevada and more particularly described as the North 1/2 of the West 1/2 of
10 LOT 24 and the South 33.25 feet and the West 1/2 of LOT 23, all in Artemisia Subdivision,
11 according to the Official Plan thereof filed in the County Records Office of Douglas County,
12 Nevada, APN: 21-202-07 to SUSAN WESTMORELAND in her official capacity as Guardian of
13 the Person and Estate of JESSICA ROACH, a minor child.
14

15 IT IS FURTHER ORDERED that when the estate has been fully administered, and Petitioner
16 has filed his supplementary accounting showing that he has paid all monies due from him, and
17 delivered up all property of the Estate of the Deceased, and has performed all acts lawfully required
18 by him, that the Court shall make a decree discharging him from all liability thereunder to be incurred.
