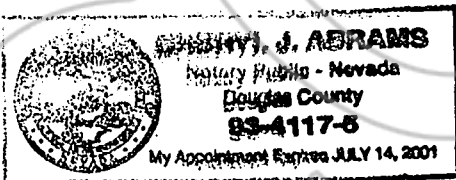

17 DEFAULT ORDER AND JUDGMENT

18 This Court has reviewed plaintiff's Application for
19 Default Judgment and all pleadings and papers on file herein,
20 and makes the following Findings and Order by way of default.

21 **AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:**

22 That the Court has jurisdiction over the parties and
23 the subject matter of this case.

24 That the defendant was personally served with a copy
25 of a Notice of Finding of Financial Responsibility on October
26 15, 1997.

27 That the defendant has failed to answer, request a
28 meeting with the district attorney's office, child support

1 division, or otherwise appear in this matter after being
2 properly served.

3 That the defendant is the parent of, and owes a duty
4 of support to: CECILIA MALICAY-CASTANEDA.

5 That based upon employment verification, defendant
6 currently earns \$1,200.00 per month. That based upon
7 defendant's monthly income and applying the formulas set forth
8 in NRS 125B.070, to wit: 18%, defendant's monthly child support
9 obligation is \$216.00.

10 That the defendant owes child support arrears in the
11 amount of \$3,024.00 for the period May 1997 through and
12 including June 1998.

13
14 **THEREFORE, IT IS HEREBY ORDERED THAT:**

15 That the defendant is the parent of, and owes a duty
16 of support to: CECILIA MALICAY-CASTANEDA, born: 05/25/97.

17 Judgment is entered in favor of Plaintiffs and
18 against defendant in the amount of \$3,024.00 for the period
19 May 1997 through and including June 1998.

20 That defendant pay \$238.00 per month, by wage
21 withholding, to be paid as follows:

22 CHILD SUPPORT: \$216.00
23 ARREARAGE PAYMENT: \$ 22.00

24 PAYMENTS MUST BE MADE TO THE DOUGLAS COUNTY CLERK AS FOLLOWS:

25 That defendant's monthly child support payments
26 shall be in the form of a cashier's check, certified check, or
27 money order, or in cash. If the payment is in the form of
28 cash, it must be delivered to the Douglas County Clerk at her

1 office in Minden, Nevada. If the payment is in the form of a
2 cashier's check, certified check, or money order, it must be
3 made payable to the DOUGLAS COUNTY CLERK, must contain
4 the notation Case No. 970256 (CASTANEDA), and be either
5 mailed to the Douglas County Clerk at Post Office Box
6 1240, Minden, Nevada 89423, or delivered to said County
7 Clerk at her office in the Law and Judicial Center, 1625 8th
8 Street, Minden, Nevada.

9 That defendant secure and maintain medical health
10 insurance on the above named child when available through
11 employment or other group policy. The defendant is ordered to
12 provide the Douglas County district attorney's office, child
13 support division information regarding the availability of
14 health insurance.

15 That the child's birth certificate shall be amended in
16 accordance with NRS 126.161 to show that ERNEST CASTANEDA is the
17 father of CECILIA MALICAY-CASTANEDA Born: 05/25/97; Born:
18 00/00/00;
19 Born: 00/00/00; and Born: 00/00/00.

20 That custody of the minor child shall remain with the
21 mother, NICHOL MALICAY. This provision is made under the
22 authority granted in NRS 126.031, and is made for the protection
23 of the minor child/ren. That the Douglas County district
24 attorney's office does not have authority to litigate matters
25 regarding custody and visitation.

26 The defendant shall notify the Douglas County district
27 attorney's office of any change in defendant's home address,
28

1 mailing address, telephone number, employment, or medical
2 insurance availability within ten days of any change.

3 In accordance with 125B.055, plaintiff and defendant
4 are hereby ordered to file with the Court and with the district
5 attorney's office their social security number, residential and
6 mailing addresses, telephone number, driver's license number,
7 and the name, address and telephone number of their employer.

8
9 **IT IS FURTHER ORDERED THAT:**

10 That defendant's first monthly child support
11 obligation shall be due on the FIRST day of JULY, 1998, and
12 shall continue due on the FIRST day of each and every month
13 thereafter until further order of this Court.

14 That when defendant's minor child emancipates,
15 defendant shall continue to pay \$238.00 per month toward
16 satisfaction of defendant's then existing child support arrears
17 in accordance with NRS 125B.100.

18 That defendant's ordered monthly payment on child
19 support arrearages does not preclude other methods of collection
20 for child support arrearages which may include, but are not
21 limited to wage withholding, garnishments, liens and the
22 interception of Federal Income tax refunds, will be undertaken
23 upon entry of this Order.

24 That this support order must be reviewed every three
25 years in accordance with NRS 125B.145 at the request of either
26 party.
