### SHORT FORM DEED OF TRUST

This Deed of Trust is made on June 16, 1998 by JAMES C. HILDMAN AND TRACY L. HILDMAN, WHO ARE MARRIED TO EACH OTHER

Bank and I agree:

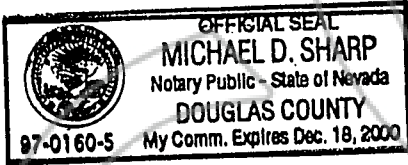
