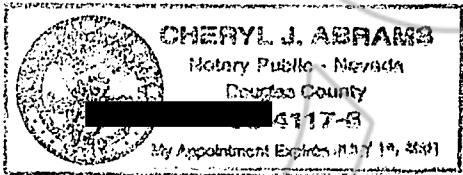

20 COMES NOW, Plaintiff GREG ROONEY, by and through GARY
21 L. KENDRICK, DEPUTY DISTRICT ATTORNEY, and Defendant, DE ANN
22 ROONEY, now known as DE ANN HALLERT, who hereby agree and
23 stipulate as follows:

24 1. That in an Order filed April 3, 1997, in the
25 Ninth Judicial District Court of the State of Nevada, Defendant
26 was ordered to pay the sum of \$251.81 per month as ongoing
27 support of her minor child, namely Jessica Renae Rooney, born
28 July 17, 1990. This sum was based upon 18% of Defendant's gross

1 monthly income or \$289.31. Defendant was also given a credit
2 of \$37.50, which sum represents one-half of her costs to provide
3 medical insurance coverage for the parties minor child. The net
4 amount of child support was \$251.81 per month.
5

6 2. That in the above-mentioned order, a judgment was
7 entered in favor of the Plaintiff and against Defendant in the
8 amount of \$925.95 for child support arrears.
9

10 3. That Defendant currently owes \$3,699.10 in child
11 support arrearages through and including June 3, 1998.
12

13 4. That Defendant is currently unemployed, but is
14 planning on returning to work on or about July 1, 1998, and
15 expects to earn \$5.25 per hour plus tips working as a gaming
16 dealer for Topaz Lodge.
17

18 5. That, however, Defendant and Plaintiff agree to
19 reaffirm the underlying support Order entered on April 3, 1997.
20 Accordingly Defendant's ongoing monthly child support obligation
21 shall be \$289.31. Defendant shall not be given credit for
22 \$37.50 for one-half of the insurance premium she pays for the
23 minor child because Plaintiff provides insurance for the minor
24 child, which is employer paid.
25

26 6. Defendant shall also pay \$25.00 per month toward
27 satisfaction of her child support arrears of \$3,699.10 for a

1 total monthly obligation of \$314.31. Defendant's first payment
2 shall be due on July 1, 1998, and continue due on the 1st day of
3 each and every month thereafter until further order of this
4 Court. Defendant shall continue to accrue child support
5 arrearages until July 1, 1998.
6

7
8 7. The parties stipulate and certify that the amount
9 of support is consistent with the appropriate formula set forth
10 in NRS 125B.070(1)(b).
11

12 8. That Defendant's child support payments shall be
13 made by wage withholding.
14

15 9. Defendant understands that, in the event she
16 becomes unemployed or underemployed, all child support payments
17 to be made by him to Plaintiff must be in the form of a
18 cashier's check, certified check, or money order, or in cash.
19 The Defendant further understands that if the payment is in the
20 form of cash it must be delivered to the Douglas County Clerk at
21 her office in Minden, Nevada. If the payment is in the form of
22 a cashier's check, certified check, or money order, Defendant
23 understands that it must be made payable to the DOUGLAS COUNTY
24 CLERK, with the notation Case No. 980020 (DE ANN HALLERT), and
25 be either mailed to the Douglas County Clerk at Post Office Box
26 218, Minden, Nevada 89423, or delivered to said County Clerk at
27 her office in the Law and Judicial Center, 1625 8th Street,
28 Minden, Nevada.

1 10. That the Plaintiff is currently providing medical
2 insurance coverage for the parties minor child which is employer
3 paid. Plaintiff shall continue to provide said insurance so
4 long as it is available to him through ^{wife} his employment.
5 Plaintiff shall provide Defendant with any and all information
6 which pertains to insurance currently in effect such as
7 insurance cards and explanation of benefits.
8

9 11. That pursuant to NRS 125B.080(7), expenses for
10 health care which are not reimbursed through insurance,
11 including expenses for medical, surgical, dental, orthodontic
12 and optical expenses, must be borne equally by both parents in
13 the absence of extraordinary circumstances.
14

15 12. Defendant agrees that she shall notify the
16 Douglas County District Attorney's Office in writing within 10
17 days of any change in Defendant's mailing address, home address,
18 or employment.
19

20 13. Defendant understands that this support order may
21 be reviewed every three years at the request of either party in
22 accordance with NRS 125B.145.
23

24 14. Defendant understands that failure to pay her
25 support as required by the order entered in accordance with this
26 stipulation will subject her to possible contempt of court with
27 a penalty of 25 days in jail.

1 15. That except as modified herein the terms and
2 conditions of the order entered April 3, 1997, in the Ninth
3 Judicial District Court of the State of Nevada, County of
4 Douglas, remain in full force and effect.
5

6 16. Defendant understands that monthly periodic
7 payments ordered in accordance with this Stipulation do not
8 preclude the use of other means to collect any arrears or
9 enforce this order, including garnishment, liens, attachments,
10 execution on real or personal property or interception of
11 federal income tax refunds.
12

13 17. In accordance with 125B.055, Plaintiff and
14 Defendant shall file with the Court and with the District
15 Attorney's Office their social security number, residential and
16 mailing addresses, telephone number, driver's license number,
17 and the name, address and telephone number of their employer.
18
