

SUBSTITUTION OF TRUSTEE

WHEREAS, on June 21, 1996, Andrew E. Gomez and Gulay N. 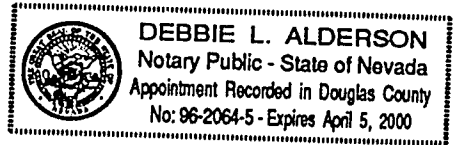
