

SUBSTITUTION OF TRUSTEE

WHEREAS, on January 12, 1995, Larry L. Legleiter and Kristin K. 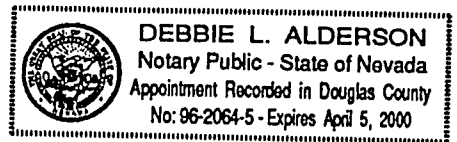
