

SUBSTITUTION OF TRUSTEE

WHEREAS, on November 17, 1996, Mark H. Madsen and Janice B. 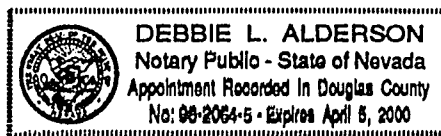
