

SUBSTITUTION OF TRUSTEE

WHEREAS, on June 19, 1993, Earl J. 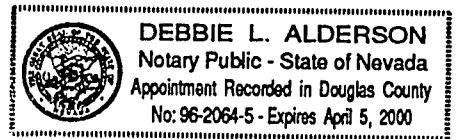
