

SUBSTITUTION OF TRUSTEE

WHEREAS, on November 14, 1990, Lester D. 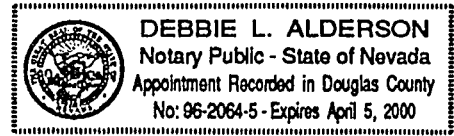
