

SUBSTITUTION OF TRUSTEE

WHEREAS, on July 18, 1988, Fredric S. 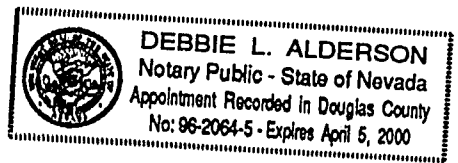
