

SUBSTITUTION OF TRUSTEE

WHEREAS, on December 8, 1992, Andrea L. Quinn, an unmarried woman and Virginia E. 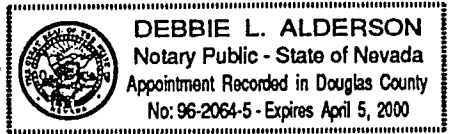
