SHORT FORM DEED OF TRUST

This Deed of Trust is made on July 21, 1998 by

Bank and I agree:

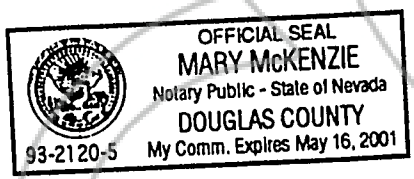

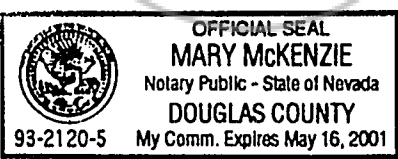
