

SUBSTITUTION OF TRUSTEE

WHEREAS, on December 12, 1992, Tina M. 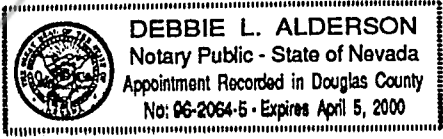
