

SUBSTITUTION OF TRUSTEE

WHEREAS, on November 11, 1989, Gerhard E. Siebertz and Charline M. 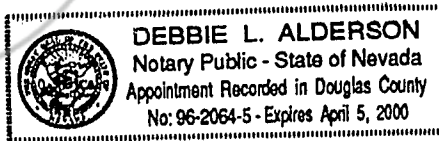
