

SUBSTITUTION OF TRUSTEE

WHEREAS, on November 18, 1995, Robert C. Stetson and Maria D. 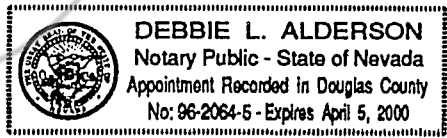
