

SUBSTITUTION OF TRUSTEE

WHEREAS, on July 14, 1990, James Summers and Diane G. 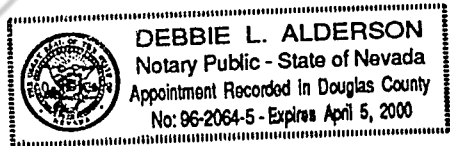
