

SUBSTITUTION OF TRUSTEE

WHEREAS, on July 22, 1994, Daniel S. Vasquez and Sonya L. H. 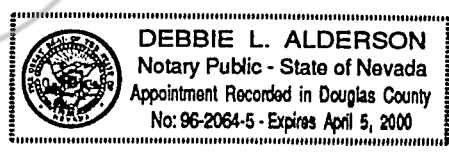
