

SUBSTITUTION OF TRUSTEE

WHEREAS, on February 8, 1997, Gary P. Warner and Markelle J. 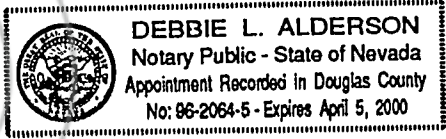
