

SUBSTITUTION OF TRUSTEE

WHEREAS, on September 28, 1991, Carrol W. 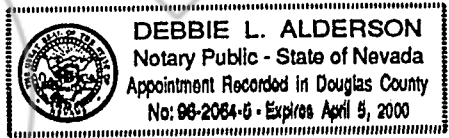
