

SUBSTITUTION OF TRUSTEE

WHEREAS, on December 26, 1992, Raymond A. Wolf and Angelita C. Wolf, husband and wife as joint tenants with right of survivorship executed that certain deed of trust dated December 26, 1992 to Stewart Title of Douglas County, A Nevada Corporation as trustee ("Initial Trustee") for the benefit of Harich Tahoe Developments, a Nevada general partnership, beneficiary, encumbering real property situated in Douglas County, Nevada, which deed of trust was recorded in the Official Records of said County on January 8, 1993 in Book 193 at Page 804 as Document Number 296932 (the "Deed of Trust"); and

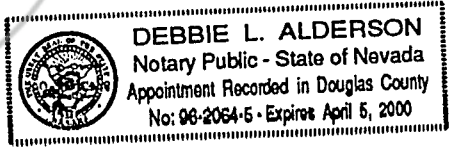
