

SUBSTITUTION OF TRUSTEE

WHEREAS, on July 21, 1991, Myrna C. 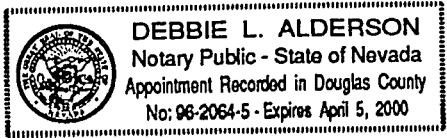
